The papers submitted on time (no later than September 10, 2020) will be subject to a *peer review* process conducted by conference scientific reviewers in accordance with the relevant international scientific standards.

The Scientific Committee reserves the right to refuse acceptance of papers that do not fall within the thematic area of the Conference, do not meet the requirements of scientific evaluation (appropriate scientific level, topicality of the theme, novelty character versus existing doctrine, relevancy of case law analyzed, content of the paper concordant with the legislation in force at the time of submission) or of those that are not reconsidered and revised within a reasonable timeframe, according to the comments and suggestions of the Scientific Committee.

Accepted papers will be published, in English, in the *conference proceedings* – a supplement to "*Valahia University Law Study*" Journal, a specialized publication BDI indexed: EBSCO, WorldCat, Index Copernicus, and accredited by CNCSIS.

1 Information regarding fee payment:

The participation fee is **200 Lei (45 Euros)**. The fee is per paper, not per author. An author can participate with at most two papers (sole author/co-author).
